

Board Meeting Minutes

July 20, 2017

The monthly meeting of the Bay Tree Lakes (BTL) Property Owners Association (POA) Board of Directors (Board) was held in the Clubhouse on Thursday, July 20, 2017.

Four Board members were present: Charles Atkinson, Bob Latham, Junior Rideout, and Troy Votaw. Treasurer Billy McGavock was unable to attend. POA Clerk Tish Herrman, Property Manager Jim Crayton and Assistant Secretary Hank Howell were also in attendance. Mr. Atkinson called the meeting to order at 7:03 pm and welcomed all attendees. He then asked Bob Latham to provide the invocation.

Approval of Prior Meeting Minutes (June 15, 2017): A motion to approve the minutes of the June monthly meeting was made by Troy Votaw and seconded by Junior Rideout. Unanimous affirmative vote by those present. The minutes of the monthly meeting will be posted on the BTL POA website, www.baytreecommunity.com

Approval of Prior Month's Financial Report (June 2017): Billy McGavock presented the report for June via email prior to the meeting, It is attached herein as Exhibit B, and the financial summary is shown below. POA Clerk's Report (June 2017): The report was presented by Tish Herrmann, and is attached as Exhibit C. Motion to approve the report was made by Junior Rideout and seconded by Troy Votaw. Unanimous affirmative vote by those present.

Property Manager's Report (June/July): The report was presented by Jim Crayton and is attached herein as Exhibit D. Motion to approve the report was made by Troy Votaw and seconded by Bob Latham. Unanimous affirmative vote by those present. The report contained a summary of the actions involving the house fire at 596 N. Horsepen the previous night. Donations to assist the residents, Todd Karpinski and Tricia Switzer, should be coordinated through Maryellen Robeson. This was confirmed by Ms. Robeson later in the meeting.

Old Business:

- •Foreclosures/Liens of Properties. Mr. Latham reported no changes in the status of attorney-related issues. Mr. Atkinson asked Mr. Latham to ask of the attorney the status of the foreclosures on the Britt Estate.
- •Drainage on South Horsepen. Mr. Atkinson reported that he continues to work with Mr. Jones to get some action on the drainage issue. Our goal is to get this done so we can proceed with obtaining road ownership.
- •Steve Jones Sr. Memorial. Troy Votaw reported that he is waiting for some wording for the memorial from Steve Jones Jr.

July 4th Celebration Plans: Mr. Crayton reported that all events for the celebration on July 1st were successful and appeared to have the largest crowds ever. Larry and Brenda Barnes, organizers of the Youth Fishing Tournament, reported that 33 young people participated and received T-shirts courtesy of White Sand Realty. A more detailed report is attached herein as Exhibit E..

Policy for Back Dues at Un-Amalgamation: Mr. Atkinson proposed that this subject should be discussed first in an Executive Session, to be held following this meeting. (The major outome of that discussion was that Troy Votaw will draft a policy for further consideration.)

Horsepen: Lake Level: Although there were reports that the level of Horsepen Lake is now below the level of the drainage pipe(s), meaning the lake no longerr is being drained, there is still concern that the level is too low and will continue to be so unless steps are taken to raise the level of the drainage pipe(s). The dicussion of possible steps naturally evolved to the question of funds to pay for those steps, most of which will be very expensive. Many voices were in favor of raising the money from the property owners, either with raised dues or a one-time assessment, or both. Mr. Atkinson agreed to research other POA's to determine their monthly dues and related benefits.

There being no further business, a motion to adjourn was made by Troy Votaw and seconded by Junior Rideout. The meeting was adjourhed at 8:28 pm..

Property Mgr. Report June/July 2017

- 1. Cards and stickers-see last page
- 2. Had PM done on exercise facility. Technician recommended replacing two foam pads on one of the machines. Cost was prohibitive. I will try to find parts elsewhere. Also, the oldest treadmill has reached the end of it's usefull life and it will be disposed of for safety reasons. (It was NOT a commercial grade machine) Since the PM visit, a problem has developed with one of the other treadmills. After talking with the technician, I have ordered the part needed and will install it myself to save the service fee
- 3. Had quarterly pest treatment done on common properties by State Pest They are also coming back tomorrow to re-do our fire ant treatment.
- 4. Worked on pool gate and got it fixed again. After trying several different pairs of wires over several days, we found a pair that works. So far, so good. Thanks to Phillip Warwick for his assistance.
- 5. Replaced fence posts and rails at Horsepen lift. I am also working with our landscaper to remove the remaining bushes and seedlings at the Horsepen Lift.
- 6. Fire inspections were done this week on pool and cabana properties. Everything was A OK.
- 7. The card reader at the main gate stopped working Saturday. I called Monday and the technician came a few hours later. He replaced the card reader and it's power supply. He also replaced the backer board in the resident gate that has not been closing properly. No problems reported since then. Since we have been having so much trouble with the gates, I also requested a quote on replacing the three gates with new hardware.
- 8. We have been having a problem with gate codes being abused and I have cancelled several. I am in the process of purging the system of as many as I can. We might want to revisit the policy.
- 9. Fourth of July activities went very well. We had good participation in the fishing event and what I think was our largest crowd for the fireworks show. Thanks to all who played a part.
- 10. The "Dive in Movies" on Friday nights seem to be going very well also.
- 11. Finally, as you are aware we had a serious house fire last night at 596 N. Horsepen-Todd Karpinski. The first in Bay Tree Lakes since the establishment of the department. Alarm came in at 6:09 PM. House was fully involved on arrival and was ultimately a total loss. Response: 6 Fire Departments plus EMS. 44 total personnel and 13 apparatus. The Bay Tree VFD stayed on scene until about 1:00 AM trying to extinguish hot spots. Recalled at 5:55 AM due to a rekindle and the department has been back several times during the day today to cool it down. The house will likely smolder for another day or two. A great effort was made to keep the fire from spreading to the house next door which was also a log cabin. Cause has not been determined at this time.
